# **Valuation of Minority Interest in an Involuntary Dissolution Action**

An involuntary dissolution action can be brought by minority interest holders (50% or less) in an effort to force a corporation or an LLC to liquidate and dissolve. More of these actions are brought in a struggling economy. If the corporation or the majority interest holders want to avoid dissolution, they can exercise their right to purchase the minority ownership interest under Cal Corp Code §2000 (corporations) or §17351 (limited liability companies). Come learn about the statutory procedure and recent holdings concerning the unique valuation method of minority interest in such an action to avoid involuntary dissolution.
