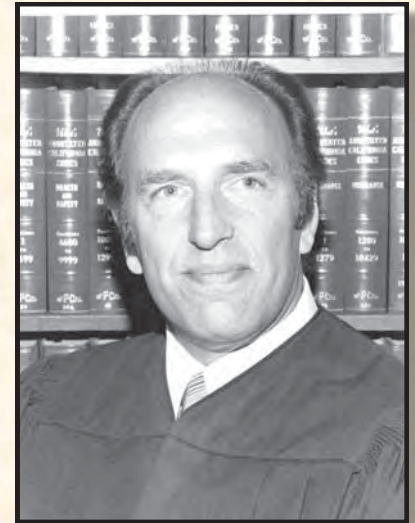
REX SATER AWARD DINNER
